THE FRANKIE LEMMON SCHOOL & DEVELOPMENTAL CENTER PROVIDES EDUCATION FOR CHILDREN WITH DEVELOPMENTAL DISABILITIES AND DELAYS IN AN INCLUSIVE SETTING. THE SCHOOL HAS THE CAPACITY TO SERVE UP TO 100 CHILDREN, BUT DUE TO THE PANDEMIC THE NUMBER OF CHILDREN SERVED FLUCTUATED SIGNIFICANTLY DURING THE FISCAL YEAR. THE MAJORITY OF CHILDREN SERVED HAVE SPECIAL NEEDS, HOWEVER, THE SCHOOL DOES SERVE TYPICALLY DEVELOPING CHILDREN AS WELL.
